What is an IEP?

An Individual Education Program (IEP) is a required document for all students receiving special education services. As part of the Individuals with Disabilities Education Act (IDEA), the IEP is a planning tool that is commonly built around four major areas that reflect the need for instruction and service delivery. Each student's IEP must be based on the least restrictive environment (LRE), and these decisions must be made on an individual student basis. See www.doe.mass.edu/sped/iep.

What is a 504 Plan?

A 504 Plan is a legal document falling under the provisions of the Rehabilitation Act of 1973. The term "504" refers to the section of the Rehabilitation Act specifying this document. It is designed to plan accommodations and modifications to assist students with disabilities (as defined under the Rehabilitation Act) to have access to educational opportunities. A 504 plan is not an Individualized Education Program (IEP) as is required for special education students.

What are some key differences between an IEP and a 504 Plan?

Section 504 does not require written plans. Section 504 protections follow the child after he/she leaves school. IEP does not. Section 504 of the Rehabilitation Act covers several areas: preschool, elementary and secondary schools, employment practices, accessibility, health, welfare, and social services. The school must notify the parent that a 504 plan has been developed but does not have to invite the parent to a meeting while it is being developed. what does he/she do?	and handles all documentation. The Chairperson is usually a special education liaison, though it can also be a coordinator or the school's team chair.
Can I see a draft of the proposed IEP prior to my meeting?	A draft may be developed together as a team. The purpose of the meeting is for the Team members to develop the IEP together, so the final IEP will not be written until after your team meets. You are encouraged to provide the Chairperson your ideas, information or concerns ahead of time that you would like to discuss.
Can I invite others to the meeting?	Yes. You may invite others who have knowledge regarding your child. Please inform your team in advance of additional attendees. Also, beginning no later than age 14, students are required to be invited to their team meeting. Families determine at what age students start attending all or part of their Team meeting.
What happens if we run out of time in the IEP meeting?	You can arrange with your Chairperson to set up additional time to meet with one or more Team members.
I am not happy with the proposed IEP I received. What is the next step?	If you feel changes need to be made to the IEP, contact your Chairperson right away. Your Team can work with you to address your concerns. You also have the option of rejecting part or all of an IEP.
I don't think we will be able to sign and return the IEP within 30 days of the meeting. What will happen?	There is no penalty for returning the IEP late, but you are encouraged to return it as quickly as possible so that your child's team can begin implementing the IEP. If you have a current IEP already in place, it will remain until you sign the new IEP.

TRANSITIONS IN THE MANSFIELD SCHOOLS: 5 THINGS TO KNOW

Roland Green to Robinson (Pre-k to Kindergarten)

- 1. A Robinson representative will attend your spring transition meeting to discuss supports and programming.
- 2. Robinson supports inclusion opportunities as well as substantially separate programs.
- 3. Specialized support services are available.
- 4. Administrators aim for balanced classroom placements.
- 5. Kindergarten Screening usually takes place in late May.

Robinson to Jordan Jackson (2nd Grade to 3rd Grade)

- 1. Transition night is held each year in the spring for the upcoming school year with all parents.
- 2. There is close collaboration between the schools to ensure a successful transition.
- 3. Curriculum and programming is consistent and developmentally appropriate throughout the elementary years.
- 4. Administrators aim for balanced classroom placements.
- 5. Jordan Jackson supports inclusion opportunities as well as substantially separate programs

Jordan Jackson to Qualters (5th Grade to 6th Grade)

- 1. Transition begins in Grade 5 at Annual Review meetings.
- 2. Students are assigned to Teams where they travel from one classroom to another on a small scale.
- 3. Academic content is delivered in Small Group and General Education settings based on the needs of the student.
- 4. Study Skills is offered to develop organizational skills and to allow preview and review of academic material, in place of an elective.

5. Students are invited to participate in their IEP meetings and Transition Planning Forms begin appearing on IEP's beginning at age 14.

Qualters to Mansfield High (8th Grade to 9th Grade)

- 1. Classes begin to be leveled Honors, College Prep, Comprehensive.
- 2. Schedules are developed based on individual student needs and interests.
- 3. Recommendations are made by Grade 8 teachers based on a number of factors.
- 4. IEP TEAMS begin focusing on Post Secondary Planning (Graduation/ Age 22).
- 5. Students are presented with wider variety of academic opportunities.

Transition Planning: For students with severe disabilities, a Chapter 688 referral is made two years prior to graduation or turning 22. One year prior to graduation a representative from an adult agency will be invited to attend a Team meeting.

Special Education Timelines

- School has 5 days of receipt of referral to provide parents with consent forms.
- School has 30 days of parental consent to evaluate a child with credentialed, trained specialists.
- School has 45
 days of parental
 consent to
 determine if a child
 is eligible for
 special education
 services.
- School has 10 school days to send 2 copies of the IEP to the parent.
- Parent has 30 calendar days to accept, reject or reject portions of the IEP.
- School has 5 days to report the Bureau of Special Education Appeals if IEP was rejected. Parent may request a meeting at any time.
